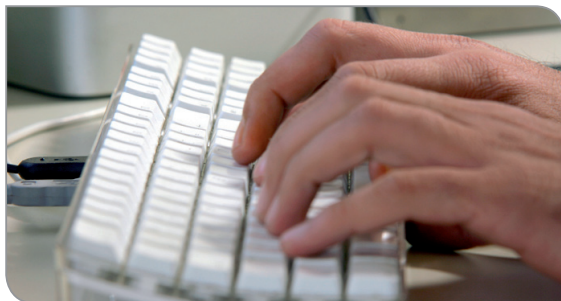

If your publication in an Open Access journal meets the funding requirements, the publication fees will be paid from the KIT publication fund up to a maximum gross amount of EUR 2,000!



OPEN ACCESS PUBLISHING

Open Access (OA) stands for unrestricted, cost-free access to scientific publications. OA verifiably improves information supply and research transfer of scientists worldwide and it increases the impact and visibility of publications in the long term.

KIT wishes to make publications of its research facilities freely accessible on the Internet according to the principles of OA.

„Publications of Karlsruhe Institute of Technology are to be freely accessible in the future, unless prevented by agreements with publishing companies and other parties. KIT encourages its researchers to publish their findings in Open Access journals.“ (KIT Executive Board, March 2010)

PUBLISHING IN OPEN ACCESS JOURNALS

Publishing in Open Access journals entails costs in form of Open Access publication fees (Article Processing Charges, APCs) that have to be borne by the author.

KIT PUBLICATION FUND

KIT Publication Fund is a service to fund these fees and to reduce the costs for the authors. All funded publications will be made available cost-free in full text on KITopen, the central repository of KIT.

FUNDING REQUIREMENTS

The complete article processing charges are paid from the KIT Publication Fund if the following requirements are met:

- The article is published in a journal whose contributions are fully and directly accessible on the Internet free of charge (“genuine open access journals”).
- The journal applies strict quality assurance procedures recognized by the respective discipline (peer review). An overview of these journals can be found in the Directory of Open Access Journals at www.doaj.org.
- The submitting/corresponding author is an employee of Karlsruhe Institute of Technology.
- The maximum funding amount is 2,000 EUR (including VAT).
- Publications funded under the funding program are to contain the following acknowledgement: *We acknowledge support by the KIT Publication Fund of the Karlsruhe Institute of Technology.*

Funding does not cover:

- Papers made freely accessible for an extra author charge parallel to being published in a subscription-based journal (so called “hybrid journals”).
- Articles restricted by an embargo period.
- Publication costs that can be paid by third-party funds.

HOW TO APPLY FOR FUNDING

KIT Library tries to minimize your administrative expenditure.
